Subsidiary in China changes name to NITTOSEIKO TECHNOLOGY (ZHEJIANG) CO., LTD.

~ Aiming to expand domestic business as a comprehensive manufacturer of fastening, assembly, and analysis technologies ~

NITTOSEIKO CO., LTD. has announced that its Chinese subsidiary, NITTO PRECISION SCREW INDUSTRIAL (ZHEJIANG) CO., LTD., will change its company name to NITTOSEIKO TECHNOLOGY (ZHEJIANG) CO., LTD. and commence operations effective July 1, 2025.

The purpose of the name change is to expand sales channels to non-Japanese companies and evolve our business as part of the NITTOSEIKO Group's growth strategy, thereby further accelerating the global expansion of our group.

■Purpose of the Company Name Change

NITTOSEIKO operates in the fastener, Assembly machines, control, and medical equipment industries, with each segment pursuing its own business expansion strategy. Through collaboration among group companies both domestically and internationally, we are committed to addressing our customers' manufacturing challenges. Within our group, we have companies engaged in manufacturing, wholesale, and retail, each leveraging their unique strengths to sell their respective products. However, in recent years, NITTO PRECISION SCREW INDUSR|TRY (ZHEJIANG) has identified the growth of the Chinese economy as a business opportunity and has focused on the assembly machines (automatic screw tightening machines) and control (analysis instruments) businesses, gradually increasing their sales ratio. In this context, NITTO PRECISION SCREW INDUSTRY (ZHEJIANG), which also handles products other than fasteners, decided to remove “screw” from its company name to expand its scope from a screw specialty company to a company handling products across segments of our group.

Taking this opportunity, NITTOSEIKO TECHNOLOGY (ZHEJIANG) CO., LTD. will focus on high

value-added, high-performance components in the fastener business. Furthermore, we will increase the ratio of our assembly machines and control businesses to establish ourselves as a comprehensive manufacturer of fastening, assembly, and analysis products.

The company is located in Jiashan, Zhejiang Province, approximately 80 km from the Port of Shanghai, the world's largest cargo port, and enjoys a favorable geographical location. It manufactures and sells machine screws ($\phi 1.4$ to $\phi 10$), tap-tight screws, precision screws, and special cold-forged parts, with a production capacity of 230 million pieces per month. Additionally, the company manufactures, sells, and provides maintenance for automatic screw tightening machines, offering total solutions.

Since 2024, the company has begun sales as the sole distributor in China for analytical instruments (Nittoseiko Analytech), aiming to establish ourselves as a high-end company with advanced technical capabilities.
